Please read the following and ensure that your child understands the importance of following these guidelines. The driver is there to ensure that everybody has a safe journey.

**Get onto the bus sensibly, do not alight until the bus has stopped**

**Show your pass to the driver, or Inspector when requested**

**Whilst travelling, remain seated where seats are available. Do not stand on the staircase or platform.**

**Do not obstruct gangways.**

**No Spitting**

**SMOKING IS NOT PERMITTED ON ANY BUSES**

**Do not cause damage to the vehicle**

**Do not tamper with emergency exits or windows**

**Do not throw objects from the windows or shout from them**

**Be polite and courteous to the driver and other passengers on the bus**

If pupils do not follow the code of conduct and their behaviour endangers other passengers or the driver, the pupils right to travel with Mike de Courcey Travel Ltd will be reviewed. If a pupil is suspended from using the bus **IT IS THE PARENTS OR LEGAL GUARDIANS RESPONSIBILITY FOR ENSURING THEY GET TO SCHOOL.**

School bus passes are not transferable and are solely for the use of the pupils name that appears on it.

Any child that knowingly allows their bus pass to be used by any other person with the intent to avoid payment may at the discretion of the company be refused travel on any service operated by Mike de Courcey Travel Ltd.

## **PROCURING TRAVEL BY DECEPTION IS A CRIMINAL OFFENCE**

It is the responsibility of the person to whom the pass is issued to ensure that the pass is taken care of. Mike de Courcey Travel Ltd undertakes to replace lost, stolen or defaced passes on application, subject to an administration charge. This charge will rise if the pass has to be replaced more than once in an academic year.

A valid pass must be produced on each occasion that the service is used and also, if required by an authorised officer of the company. Failure to do will result in a fare being paid.

**\* TO AVOID ABUSE TO THE SYSTEM IF A VALID PASS IS NOT SHOWN AND A FARE IS NOT PAID, THE COMPANY RESERVES THE RIGHT TO REFUSE TRAVEL \***

Drivers, Inspectors and any other operational staff may, at their discretion withdraw a pass if they have reasonable cause to suspect fraudulent use is being made of a pass, or if it mutilated to such an extent that any of the details are illegible.

### **PAYMENT DETAILS**

Payment should be made directly to Mike de Courcey Travel for bus passes which will be issued on a half term, full term or annual basis.

Credit/Debit card payments can be made over the telephone.

For the initial pass application, credit/debit card payment must be made in person at our office in Rowley Drive, Coventry.

Payments in cash should only be made at our office in Rowley Drive, Coventry. We do not advise sending cash via the post.
